### **Multipoint Moving Nodes: the Key to Enhancing Approximate Analytical Solutions of Parabolic Equations**

#### **ABSTRACT**

This article discusses approximate solutions of linear parabolic equations with initial-boundary conditions. The primary focus is on methods that effectively find such solutions by employing a moving finite difference analog of the differential equation. This approach allows us to formulate an approximate analytical solution, significantly simplifying the computation process. By transitioning from the differential equation to an algebraic equation, we obtain a single equation, the solution of which represents an approximate analytical solution to the original problem. However, to achieve higher accuracy in this solution, we apply additional moving nodes, which enhances the results. By using multipoint moving nodes, we can form a system of algebraic equations, the solution of which provides us with an improved analytical solution. The article also presents numerical experiments that confirm the effectiveness of the proposed method and its advantages over traditional approaches.

### **The Number $\pi$ : From Antiquity to Modern Computing with Geogebra Software**

#### **ABSTRACT**

In this work, we explore the number  $\pi$  from a new perspective, using advanced mathematical methods and the GeoGebra software for investigations in Cartesian, isometric and polar coordinates. We focus on proportional relationships in the first quadrant of the unit circle, extending the analyses to the following quadrants with precision and rigorous logic. Traditionally,  $\pi$  is recognized as an irrational number, intrinsic to nature and geometry. However, our research suggests the possibility of understanding  $\pi$  in a rational and repetitive way, through divisions, infinite series, and pertinent theorems. We propose a renewed view on  $\pi$ , questioning established assumptions and enriching mathematical understanding by challenging old concepts and broadening our understanding. The methodology analyzes the relationship between circumference perimeters and their diameters, radian angles, and square roots. The integration of these factors with inscribed and circumscribed polygons indicates a rational

pattern for the number  $\pi$ . Advanced computing is essential for calculations that surpass ruler and compass capabilities. Recent studies suggest that, although traditional geometric methods do not determine an exact and repeatable value for  $\pi$ , advanced computational techniques and mathematical models can reveal new aspects of this essential constant.

## **The Vortex Impulse Theory for Finite Wings**

## **ABSTRACT**

Based on the observation that lift producing circulation is the result of divergent reflective flows circumventing planform edges, this research presents a comprehensive new theory for finite rectangular wing aerodynamics. First, it features an unconventional expression for potential lift, emphasizing geometrical aspects that reduce circulation strengths and lifting capacity. Of fundamental significance is the derivation of a novel "crossflow separation vortex normal force" through the application of a long-overlooked Milne- Thompson "Vortex Impulse Theory." An empirical non-linear pressure drag normal force relationship is also provided to complement linear theories. Since critical experimental evidence shows that potential lift is absent in narrow wing cases, it is excluded in that range and only provides limited contributions in wider configurations. This distinctive three lifting element theory is found to provide highly accurate predictions for all experimental cases evaluated.

## **Development of a Statistical Thermodynamic Model for Calculation of Self-diffusion Parameters in Metals**

## **ABSTRACT**

Diffusion is the most important transfer processes of substances and masses in metals. The theory of diffusion in metals is based on the fundamental concepts of physical kinetics and is very important branch in Material Science. The purpose of this project is to develop a statistical thermodynamic model for the self-diffusion in metals and to apply it for calculating the diffusion coefficients of atoms in metals and alloys. The relationship between the diffusion flux of vacancies and the gradient of their chemical potential has been obtained from the basic principles of statistical thermodynamics. For a solid solution of vacancies in a metal, an expression for the self-diffusion coefficient has been found. To calculate the activation energy of self-diffusion in metals and simple alloys, the statistical calculation model (SCM) was proposed that consider energy calculations from first principles, statistical processing of experimental data on self-diffusion of metals, and a physicochemical model using the correlation relationship between the activation energy of self-diffusion and the melting temperature of metals. The calculations are compared with the known experimental data on the diffusion in iron and other metals with a good agreement between the results. Based on the processing of experimental results on diffusion in metals using SCM, thermodynamic parameters of self-diffusion activation energies in  $\alpha$ - and  $\gamma$ -Fe, Ti, V, Mo, W, Ag, Cu and other metals were established. The SCM for self-diffusion in metals and simple alloys was implemented in the corresponding database, including 43 base metals and silicon.

## **On the Origin of Inertia: Implications for Dark Matter and Dark Energy**

## **ABSTRACT**

In this paper, we present a new theory explaining the origin of inertia based on two key ideas: gravity as a spin-1 gauge field theory and the relativity of all motion. This theory proposes that inertial mass is influenced by the distribution of matter across the Universe, offering potential insights into dark matter and dark energy. For gravity to be described by a spin-1 gauge field theory, we propose that gravitational mass  $m$ , distinct from inertial mass, is a Lorentz invariant and should be replaced by an imaginary mass  $im$  for like masses to attract. According to this theory, while gravitational mass is imaginary, inertial mass remains a real quantity. These two key ideas, lead to the principle of Equivalence and the conclusion that gravity shapes the geometry of spacetime, which is FinslerRanders spacetime. For bodies with gravitational mass, this curved spacetime is equivalent to a flat Minkowski spacetime with an added gravitomagnetic field. The theory shows that external inertial forces originate from the entire Universe, while internal forces depend on the body's structure. In free fall, all bodies experience only external forces, explaining why they fall at the same rate regardless of internal structure.

## **The Quantistic Nature of Space-Time**

## **ABSTRACT**

The invariance of the speed of light in RFs in motion proves that the space time is a quantistic entity, because its "density" is determined only if related to an observer. The difference of this density between two observers in relative motion is given by a set of transformation equations obtained by analysing the propagation of a flash of light in a 3D RF. They show that the RFs of the two observers are displaced, one with respect to the other, towards an imaginary direction by a spatial component transverse to the motion, and as a consequence their respective "density" is reduced by a ratio  $\sqrt{1-v^2/c^2}$ . Therefore the two observers, watching the same physical phenomenon (for example the displacement of an object from point A to point B), would measure different values for space and time, same value for velocities, but different accelerations and therefore different forces acting on the object.

## **The Nuclear Second Law**

## **ABSTRACT**

This paper asserts that the nuclear phenomena has had no traditional computational nexus with the Second Law of thermodynamics. Since N Reactor days, there has been no direct

nexus between nuclear power and its resultant energy flow delivered to the coolant. N Reactor neutron flu was not well measured, but was the motive force behind delivering 4000 MWt to the the Columbia River. It is well known that neutron flux in a 1270 MWe PWR is approximately  $1.0 \times 10^{13} \text{ n/cm}^2 \text{ sec}^{-1}$ . This flux a product of Neutron Transport Theory (NTT). However, a back-calculating a flux based on the PWR's rated 3640 MWt divided by average macro cross section, fissile volume and recoverable MeV/Fission, produces twice the NTT flux. From the time of the Manhattan Project, nuclear engineers had treated flux as a relative parameter: hard to measure, a relative value to be normalized, is not uniform, etc., etc. Postulated in this work is that nuclear phenomena are inertial processes, devoid of terrestrial reference. Such phenomena encompass fission and fusion power, astrophysics and radioactivity; all such phenomena provided the reaction produces a mass defect. This approach demands reinterpretation of Einstein's  $\Delta E = c^2 \Delta m$  by describing his  $\Delta E$  as an exergetic potential, an ultimate "Free Exergy". Free Exergy consists of both recoverable and irreversible portions of the MeV release. In transference to a coolant, the recoverable release produces an exergetic increase ( $\dot{m}\Delta g$ ) in the fluid; its exergy's  $T_{Ref}$  derives from an Inertial Conversation Factor ( $\Xi$ ). Importantly,  $\Xi$  also transforms this recoverable nuclear release to an explicit, and consistent, thermal power ( $\dot{m}\Delta h$ ).

## **Theoretical Derivation of Bohr's Postulate for the Charge in a Hydrogen Atom. Coulomb's Law in Logarithmic form with Corrections for Strong Interactions at Small Distances. The Physical Meaning of Planck's Constant**

## ABSTRACT

This article proposes a revolutionary mathematical model that introduces a fifth spatial dimension—"space density"—as a fundamental property determining gravitational, electromagnetic, strong, and weak interactions. The model is based on the hypothesis that changes in space density can lead to phenomena analogous to known fundamental forces. Through a series of mathematical derivations, it is shown how the distribution of space density around spherical objects influences classical field theories. The main results include: 1. Theoretical Proof of Bohr's Postulate: For the first time, a theoretical justification for Bohr's postulate on the quantization of the electron's angular momentum in a hydrogen atom is proposed, which is key to quantum mechanics. 2. Connection Between Charge and Mass: A novel connection between charge and mass is established, allowing mass to be interpreted as the energy required to compress a clump of space density. 3. Complex Solution and Imaginary Energy: It is shown that the interaction of two clumps of space density has only a complex solution, where the imaginary part determines the resonant frequency of the system. 4. Strong and Weak Interactions: The model offers an explanation for strong and weak interactions through the properties of space density, opening new possibilities for understanding nuclear forces. This work not only reproduces known physical regularities but also offers a new perspective on the nature of fundamental interactions, linking them to the intrinsic properties of space.

### **ABSTRACT**

## **Exploring Quantum Gravity at the Nanoscale**

### **ABSTRACT**

This study recalculates quantum gravity parameters for seven nanobumps and seven nanopits on a spinning hard disk platen, exploring nanoscale gravitational effects. The spacetime curvature metric ( $G_{00}$ ) matches provided table values, and the antigravity force for nanopits is used to calculate tunneling barrier magnitudes. Using the Puthoff model's predictions, the analysis examines a 20-nanosecond pre-signal in expanded spacetime (nanopit) and a 20-nanosecond post-signal in denser spacetime (nanobump), calculating their apparent speeds relative to the speed of light. Results are analyzed within a semiconductor-like model, spacetime metric engineering, extra-dimensional gravity, and General Relativity, including frame-dragging effects. The Casimir force is assessed for superposition with gravitational forces. The findings support magnified gravitational interactions at nanoscale distances, with tunneling-like behavior in nanopits indicating a quantum gravity regime and confirm spacetime dynamics predicted by the Puthoff model.

## **Evaluating Prompt-Learning-Based API Review Classification Through Pre-trained Models**

## **ABSTRACT**

To improve the work efficiency and code quality of modern software development, users always reuse Application Programming Interfaces (APIs) provided by third-party libraries and frameworks rather than implementing from scratch. However, due to time constraints in software development, API developers often refrain from providing detailed explanations or usage instructions for APIs, resulting in confusion for users. It is important to categorize API reviews into different groups for easily usage. In this paper, we conduct a comprehensive study to evaluate the effectiveness of prompt-based API review classification based on various pre-trained models such as BERT, RoBERTa, BERTOverflow. Our experimental results show that prompts with complete context can achieve best effectiveness and the model RoBERTa outperforms other two models due to the size of training corpus. We also utilize the widely-used fine-tuning approach LoRA to evaluate that the training overhead can be significantly reduced (e.g., 50% reduction) without the loss of the effectiveness of classification.

## **ABSTRACT**

With the development of intelligent manufacturing and industrial automation, circuit board quality inspection, as a crucial part of industrial production, urgently needs efficient and precise target detection models. This project aims to design and optimize a target detection model based on deep learning methods that can quickly and accurately identify defective circuit boards. By introducing the RepVGG structure to improve the Yolov5 backbone network and integrating multiple attention mechanisms (such as CBAM, SE, SCA, etc.), this research significantly enhances the detection performance. Experimental results show that the improved Yolov5 + RepVGG + SE model achieved an accuracy rate of 89% on the defective circuit board dataset provided by the Beijing University Intelligent Robot Open Laboratory, which is higher than other combinations.

## **Integrating Universal Generative AI Platforms in Educational Labs to Foster Critical Thinking and Digital Literacy**

## **ABSTRACT**

This study investigates the educational potential of generative artificial intelligence (GenAI) platforms based on large language models (LLMs), such as ChatGPT, Claude, and Gemini, as tools for student-centered learning. Recognizing the current limitations of GenAI—particularly its propensity for generating inaccurate or misleading information—the paper proposes a novel instructional strategy: an interdisciplinary laboratory designed to foster critical evaluation of GenAI-generated outputs. In this pedagogical model, students engage with GenAI systems by posing questions or solving problems drawn from topics they have already studied and understand. Equipped with correct answers, students are positioned to assess the accuracy, and relevance of AI-generated responses across multiple modalities, including text, images, and video. Students design such difficulty prompts and tasks which help compare the intellectual performance of various GenAI. This approach was implemented for a specially designed lab session within a general astronomy course for non-science majors. Multiple student groups completed the lab, demonstrating high levels of engagement, initiative, and critical thinking. Findings suggest that such activities not only deepen students' comprehension of scientific content of learning courses but also cultivate essential skills in digital literacy and critical interaction with AI technologies.

## **ABSTRACT**

This Research article explores the changing impact of AI (Artificial Intelligence) on automation capabilities of Copado, improving the deployment and change management in Salesforce DevOps. In this paper we have outlined the AI- based methodologies that automate the version control, optimize change management workflows, and improve accuracy of the deployments. The traditional Salesforce DevOps pipelines face many challenges like deployment errors, merge conflicts, roll back issues, and dependencies between the components.
